3 **Resolution endorsing Local Power's Community Choice Aggregation Bill of Rights, to**
4 **clarify and expand the authorities of Cities and Counties such as San Francisco with**
5 **respect to large scale solar energy, efficiency and other conservation technologies and**
6 **further urging California Senator Migden and California Assembly member Mark Leno**
7 **to jointly file aforementioned Community Choice Aggregation Bill of Rights by the**
8 **legislative deadline.**

10 WHEREAS, The Board of Supervisors unanimously passed, and the Mayor signed
11 ordinance 86-04 establishing a Community Choice Aggregation (CCA) Program, allowing San
12 Francisco to aggregate the electrical load of electrical consumers in San Francisco pursuant
13 to Assembly Bill 117; and,

14 WHEREAS, the CCA Ordinance established a mechanism for San Francisco to
15 accelerate the introduction of renewable energy, conservation and energy efficiency into San
16 Francisco's portfolio of energy resources; and; and,

17 WHEREAS, the City has a public health mandate to facilitate the rapid and large-scale
18 development of renewable energy and conservation resources within the City; and,

19 WHEREAS, in December 2002, San Francisco adopted an Electricity Resource Plan
20 calling for the development of 107 Megawatts of load reduction through electricity load
21 management and efficiency measures, 31 Megawatts of in-City solar energy, 72 Megawatts of
22 small-scale distributed generation such as fuel cells in San Francisco and 150 Megawatts of
23 new wind energy imports by 2012; and,

1 WHEREAS, Ordinance 86-04 directed City departments to work with City finance staff
2 to determine how Proposition H Bonds may be used to augment CCA by providing financing
3 for renewable energy and conservation projects, including a bond-repayment schedule based
4 on anticipated revenues collected from monthly electric bills and other sources; and,

5 WHEREAS, San Francisco residents have expressed concern that air pollution from
6 fossil fuel power generation in the City is a contributing factor in the cause of asthma and
7 other diseases; now, therefore, be it; now, therefore, be it

8 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
9 endorses Local Power's Community Choice Aggregation Bill of Rights, to clarify and expand
10 the authorities of Cities and Counties such as San Francisco with respect to large scale solar,
11 efficiency and other conservation technologies and further urging California Senator Migden
12 and California Assembly member Mark Leno to jointly file aforementioned Community Choice
13 Aggregation Bill of Rights by the legislative deadline; and be it

14 FURTHER RESOLVED, That the Board of Supervisors further urges the Clerk of the
15 Board, upon adoption, immediately send copies to California Senator Carole Migden and
16 Assembly member Mark Leno.


